**Notice:** The erection of any tent within the city limits is subject to provisions of Section 94-321 of the Zoning Ordinance. In addition to this completed application, the applicant must submit a site plan including the location of the tent and all structures, driveways, streets, right-of-ways, property lines, required setbacks, and other significant site features, as needed to review the application. **This permit is valid for a maximum of ten days, and must be displayed on the tent or be immediately available for inspection at all times that the tent is standing.**
